#### **ADOPTION OF MINUTES**

**BUDGET ADJUSTMENTS FOR YEAR END 12/31/07**

Councilman Cancel offered the following resolution, which was seconded by Councilman Gould, and on roll call unanimously adopted.

**123-08 RESOLVED, THAT THE SUPERVISOR IS AUTHORIZED TO MAKE BUDGET ADJUSTMENTS FROM THE GENERAL FUND (A) IN THE AMOUNT OF \$28,551,245.20; PART TOWN FUND (B) IN THE AMOUNT OF \$4,500.00; HIGHWAY (DA) IN THE AMOUNT OF \$117,500.00; AMBULANCE DISTRICT (SA) IN THE AMOUNT OF \$22,500.00 AND FROM THE STREET LIGHTING DISTRICT (SL) IN THE AMOUNT OF \$1,000.00 PURSUANT TO THE REPORT OF THE DIRECTOR OF FINANCE FOR THE TOWN OF HAVERSTRAW FOR THE PERIOD ENDING DECEMBER 31, 2007. **PUBLIC PARTICIPATION**

Councilman Cancel asked if the Town was going to comply with the letter that we received from the County of Rockland Department of Public Transportation regarding their proposal of a partnership with the Town by offering Super Saver volume-discounted bus tickets for the residents.

Supervisor Phillips stated that the Town Clerk's office has agreed to sell the tickets through her office.

Bruce Leach, 22 N. Wayne, West Haverstraw asked if the Town would consider using a portion of the Sanitary Landfill for flying radio controlled airplanes. Mr. Leach stated that they fly the airplanes at the Clarkstown Landfill and he was wondering if the Town's landfill could be used as a secondary field.

Supervisor Phillips stated that the Town would consider his request and asked that Mr. Leach call the Supervisor during the week to discuss this matter further.

Rose Senator, 117 Country Club Lane asked the Supervisor if he knew when she was going to get a response from the statement that she submitted at the last Town Board Meeting.

Supervisor Phillips stated that he was hoping to have her response in the mail this week.

Ilan Schulein, Thiells stated that the Town needs to bring in some type of taxable ratings from an entity or industry between the Towns of Haverstraw and Stony Point, and Tomkins Cove. We have to compensate for some of the loss from the Mirant tax lawsuit.

Supervisor Phillips stated that there is not a lot of land left in the Town of Haverstraw. We are working with United Water for them to have a desalinization plant online in 2013 next to Bowline. The Village of Pomona opposed housing and a shopping center at the sand and gravel pit. The Town has Empire Zones and if a business comes into the area, the state will pay the taxes for the first 10 years. I am continually meeting and speaking with the members of the Rockland Economic Development Corp. seeking to locate businesses to the Town of Haverstraw. We also offer business tax exemptions to encourage businesses to the Town. This must be a constant work in progress and we will continue to do everything in our means to attract businesses to the Town and Villages.

Councilman Cancel stated that it's frustrating because the Town does not own the 50 acres in Pomona – our hands are tied.

Ilan Schulein, Thiells asked about the land that the North Rockland school district owns located next to the golf course. It doesn't bring in any money, the land just sits there. The waterfront land in the Village would also attract a lot of people.

Supervisor Phillips stated that the only vacant piece of land on the waterfront is owned by Mirant and they are not going to sell it. Other pieces of waterfront properties are owned by Ginsburg in the Village of Haverstraw. Other than that, there is nothing vacant. Where Tilcon ends, it abuts or is coterminous with Ginsburg's property. South of Tilcon is Dutchtown, and beyond that, the land is owned by the PIP.

### **BOARD MEMBERS**

The Supervisor thanked the Highway and Parks Department for the excellent snow removal this past storm.

Legislator Michael Grant was in attendance at the meeting and he stated that there was nothing on the Legislature's agenda pertaining to the Town of Haverstraw.

**124-08** Supervisor Howard T. Phillips, Jr. stated that he would like to close tonight's meeting in memory of Susan Marie Lafalgio; Anthony P. Ercole; Assunta Filippone Moorefield; Felipe Rosa Martinez and Theresa Spicca Georgetti, who recently passed away. Supervisor Phillips, the Town Board members and the Elected Officials further extended their condolences and sympathy to the families. Thereafter, a motion was made by Councilman Gould, seconded by Councilman Soto, and the Town Board Meeting was adjourned.
