**CREATE POLICE SERGEANT POSITION FOR TOWN OF HAVERSTRAW**

Councilman Gould offered the following resolution, which was seconded by Councilman Soto, and on roll call unanimously adopted.

**361-10 RESOLVED, THAT THE TOWN BOARD OF THE TOWN OF HAVERSTRAW HEREBY CREATES THE POSITION OF POLICE SERGEANT FOR THE TOWN OF HAVERSTRAW POLICE DEPARTMENT AND BE IT FURTHER**

**RESOLVED, THAT THE ESTABLISHMENT OF THIS POSITION IS SUBJECT TO THE RULES AND REGULATIONS OF THE ROCKLAND COUNTY DEPARTMENT OF PERSONNEL.**

**APPOINTMENT OF DAVID KRYGER TO POLICE SERGEANT C/P**

The following resolution was approved by all members of the Town Board.

**362-10 RESOLVED, THAT UPON THE RECOMMENDATION OF CHARLES MILLER, CHIEF OF POLICE, THE TOWN BOARD OF THE TOWN OF HAVERSTRAW DOES HEREBY APPOINT DAVID KRYGER OF GARNERVILLE, NEW YORK TO THE POSITION OF POLICE SERGEANT, FULL TIME, CONTINGENT PERMANENT FOR THE TOWN OF HAVERSTRAW, EFFECTIVE IMMEDIATELY, AND BE IT FURTHER**

**RESOLVED, THAT MR. KRYGER HAS BEEN CLEARED ON ALL PRE-EMPLOYMENT TESTS BY THE ROCKLAND COUNTY DEPARTMENT OF PERSONNEL, AND BE IT FURTHER**

**RESOLVED, THAT THIS APPOINTMENT IS SUBJECT TO THE RULES AND REGULATIONS OF THE ROCKLAND COUNTY DEPARTMENT OF PERSONNEL, AND MR. KRYGER SHALL SERVE A PROBATION PERIOD OF TWO (2) YEARS.**
