**AGREEMENT BETWEEN THE COUNTY OF ROCKLAND NARCOTICS TASK FORCE AND THE TOWN OF HAVERSTRAW**

Councilman Gamboli offered the following resolution, which was seconded by Councilman Soto, and on roll call unanimously adopted.

**464-10 RESOLVED, THAT THE TOWN BOARD OF THE TOWN OF HAVERSTRAW DOES HEREBY AUTHORIZE HOWARD T. PHILLIPS, JR., SUPERVISOR TO ENTER INTO AN AGREEMENT WITH THE COUNTY OF ROCKLAND FOR REIMBURSEMENT OF A POLICE OFFICER ASSIGNED TO ROCKLAND COUNTY NARCOTICS TASK FORCE FOR THE YEAR 2010 IN THE SUM OF \$174,485.00, AND BE IT FURTHER**

**RESOLVED, THAT THE TOWN BOARD AUTHORIZES THE SUPERVISOR TO AMEND THE CONTRACT TO REFLECT THE ACTUAL AMOUNT THAT THE OFFICER EARNED DURING FISCAL YEAR 2010.**

**RESOLUTION AUTHORIZING THE SUPERVISOR TO APPLY FOR A GRANT FROM THE NEW YORK STATE DEPARTMENT OF STATE ON BEHALF OF THE TOWNS OF CLARKSTOWN, ORANGETOWN, HAVERSTRAW AND STONY POINT**

**The following resolution was unanimously adopted by all members of the Town Board.**

**465-10** WHEREAS, the Supervisors of the Towns of Clarkstown, Orangetown, Haverstraw and Stony Point, recognizing the exemplary work and contribution of the men and women in their respective police departments, propose a feasibility study for the consolidation of the police departments currently operates separately in each municipality in order to reduce the cost and size of government; and

WHEREAS, the Towns of Clarkstown, Orangetown, Haverstraw and Stony Point wish to obtain the Local Government Efficiency (LGE) Hi Priority Grant in the program year 2010-2011 from the New York State Department of State for monetary assistance in carrying out the project known as the Study for the Consolidation of Police Departments in Rockland County; and

WHEREAS, the Town of Clarkstown is to be the lead agency for such grant, and the Towns of Orangetown, Haverstraw and Stony Point will be co-applicants, which pursuant to an intermunicipal agreement shall reimburse the Town of Clarkstown for the expenditures rendered in order to complete the named project;

NOW, THEREFORE, be it

RESOLVED, that the Town Board of the Town of Haverstraw hereby authorizes the submission of an application to the New York State Department of State for a grant in the amount of \$27,000 for reimbursement of said project; and be it

FURTHER RESOLVED, that the Town Board of the Town of Haverstraw hereby authorizes a 10% contribution or the balance of the project as the local share for the project costs, of which will be reimbursed proportionately by the participating Towns to be in an intermunicipal agreement to be signed at a future date; and be it

FURTHER RESOLVED, that the Supervisor is authorized to execute said application on behalf of the Town of Haverstraw and take all necessary actions to implement this resolution.
