**PUBLIC HEARING – HOUSES OF WORSHIP AND OTHER RELIGIOUS USES**

Supervisor Phillips stated that the purpose of this Public Hearing is to discuss the consideration of adopting a local law to add a new section providing for the location of houses of worship and other religious uses.

**PRESENTATION BY KATHY ZALANTIS, PLANNING ATTORNEY & MICHAEL KAUKER, TOWN PLANNING CONSULTANT**

While the Town of Haverstraw has always welcomed diverse uses which support religious exercise, the current zoning ordinance is lacking in adequate regulations clearly making provision for such uses, while also providing a manner of balancing potential impacts of such uses on community character and resources. If someone new wanted to come in and build a house of worship under Federal law you cannot preclude this. A special permit is required and site plan approval from the Planning Board is necessary. Town Attorney, William Stein stated that there was no history of a problem because no religious use or approval has never been denied. The Zoning Ordinance of the Town of Haverstraw is amended to add a new section entitled, "Houses of Worship and other Religious Uses," which allows for churches, synagogues, etc. to be permitted as of right in every zoning district in the Town. Schools, meeting halls and community centers, which conduct activities accessory to houses of worship are permitted on any lot containing a house of worship, and Bulk Regulations for all uses permitted pursuant to this section. The minimum lot size is one acre in size and the size of the building is also limited as well as recommending certain parking restrictions. An environmental review was prepared and Parts I & II were submitted to the Town Board. The Town Board will act as Lead Agency and there is no significant environmental impact on the community.

**RESOLUTION ADOPTING PROPOSED LOCAL LAW NO. 1 OF 2011**  
**AMENDING THE TOWN ZONING CODE**

**59-11** WHEREAS, the Town Board recognizes that by both State and Federal Law, uses which carry out and implement religious exercise are protected, so as to ensure that local regulations do not unduly burden religious exercise, and

WHEREAS, mindful of the limitations placed upon local regulation of such uses, this local law amending the Town's zoning regulations has been proposed in order to establish an appropriate balance between religious uses and the substantial interests the Town of Haverstraw has in protecting the public health, safety and welfare, and

WHEREAS, Town Board has caused a long form environmental assessment form to be prepared, and

WHEREAS, the Town Board has conducted a duly noticed public hearing on the proposed amendments, and

WHEREAS, the Town Board makes the following findings:

The proposed local law is consistent with the mandates of state and federal law requiring that land use regulations of a community do not unduly burden religious practice and provides a balance between permitting such uses and placing reasonable regulations on such uses so as to protect the public health safety and welfare,

NOW THEREFORE,

BE IT RESOLVED, that the Town Board declares itself lead agency pursuant to the State Environmental Quality Review Act (SEQRA) and finds this to be a TYPE I action under SEQRA, and

BE IT FURTHER RESOLVED, that the Town Board hereby adopts the annexed SEQRA Negative Declaration finding that the proposed amendment requires no further environmental review, and

BE IT FURTHER RESOLVED, that for the foregoing reasons the Town Board hereby adopts Local Law No. 1 of 2011 as proposed.
