<u>Supervisor Phillips</u> stated that revenue was down by \$200,000 which was directly attributed to the weather that we had in the beginning of the spring, rain on the weekends, Hurricane Irene and the snow storm in October. We will have the figures when the annual report comes out. We are very pleased with the amount of rounds we had these past couple of months.

Mary Panella, Call Hallow Road, Pomona asked the Board why would you run a golf course if there was no profit.

Supervisor Phillips stated that is a very good question and that there was over 100 acres there and if we did not construct a golf course there, the State would have sold it and a developer would have built a few hundred homes. The golf course adds value to the homes. Our golf course normally breaks even and some years we make money. This has been a freak year with the weather. About 10 years ago we did a major rehaul of the course for \$2 million. The golf course is an amenity that adds to the community and will be kept "forever green." Many youth organizations, high schools, senior citizens, men's leagues, St. Peter's and St. Gregory's parish utilizes the course. There were approximately 70 outings last year and numerous tournaments.

Mary Panella, Call Hallow Road, Pomona stated that she was an angry American. She also stated that the board took an oath and if any of them read the N.Y.S. Constitution.

Supervisor Phillips stated that the N.Y.S. Constitution is hundreds of pages.

Mary Panella, Call Hallow Road, Pomona stated that the fact that this is a one party town is not your fault. I give the credit to the people that live here. When you have a resolution you people have a vote and it's all decided before you come before the meeting. If I have anything to say does it matter? Just a question you need to think about. I am generally upset about what is going on in this country. How many of you know about Agenda 21. What will there be for our children and my grandchildren if our freedom is corrupt.

Supervisor Phillips stated that he can understand her concerns and frustration but the nation level politics and local are completely different. We have remained accountable to the people. The Town went through an extensive delineation of where our expenses were and they are the New York State Retirement; New York State Health Care Benefits; police binding arbitration; mandated to provide worker's comp and the Bowline/Mirant. Take those expenses out of the budget and there is a \$93,000 decrease in the budget. We have the lowest town taxes in Rockland County. The Town needs more ratables and we are trying to attract more businesses. It is not the town tax it's the school tax that is the lion share of property tax. We also have the lowest sewer tax in Rockland County – it's one of the best. More restaurants are opening in the Village of Haverstraw. 65% of our budget is the police. We are trying to persuade the Governor to change the Taylor Law. We have had the most affordable government since past Supervisors Rotella and Lawless, which we have continued. In the good times everyone was spending the money. We remained fiscally responsible. We cannot afford a new police station. We put a small addition on the station. We repaved roads and installed Belgium Block without using taxpayers money – we secured grants. The trucks we are purchasing are 21 years old from 1985 and 1987.

Supervisor Phillips read a letter from one of our residents, Kevin Kelly, congratulating the Town Board for incorporating the Rockland County Youth Police Academy and for their continued support of this wonderful program.
