PUBLIC HEARING FOR LOCAL LAW NO. 4-2012
TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL
LAW 3-c

Supervisor Phillips announced that this Public Hearing is being held for the purpose to consider Overriding the Tax Levy Limit Established in General Municipal Law 3-c.

The Deputy Town Clerk read proof of publications and presented the Affidavits of Publication to the Board.

PRESENTATION BY SUPERVISOR HOWARD T. PHILLIPS, JR.

As we have stated before, there are three reasons why we have to override the tax levy. The reasons are as follows: 1. Increases the Town received from the State on police and employee retirement and health insurance; 2. Increases the Town received from the County of Rockland such as college tuition reimbursement; Board of Election fees; Intell Officers and Narcotic Task Force discontinuing of reimbursement and 3. Binding police arbitration – we do not have a contract and based upon the history of the other Police Departments in Rockland County, we made an estimate. When you add up all of these increases, they far exceed the 2% tax cap.
