THE COUNTY NARCOTICS AND INTEL UNITS ABSENT AN AGREEMENT BY  
APRIL 15, 2012**

Councilman Soto offered the following resolution, which was seconded by Councilman Cancel, and on roll call unanimously adopted.

**196-12 WHEREAS, THE SHARED NARCOTICS AND INTEL PROGRAMS HAVE BEEN LARGELY SUCCESSFUL, ENABLING THE TOWN OF HAVERSTRAW TO LEVERAGE RESOURCES TO PREVENT CRIME, AND**

**WHEREAS, THE COUNTY HAS IN YEARS PAST REIMBURSED THE TOWN FOR THE FULL COST OF TWO (2) POLICE OFFICERS ASSIGNED TO THESE UNITS, AND**

**WHEREAS, THE COUNTY HAS PROVIDED THE TOWN WITH NEITHER PAYMENT FOR THE FIRST QUARTER OF 2012, NOR ANY SORT OF CONTRACT FOR 2012, AND BY ALL APPEARANCES IS IN DEEP FINANCIAL TROUBLE, AND**

**WHEREAS, THE COUNTY EXECUTIVE HAS ALSO ELIMINATED OR THREATENED TO ELIMINATE FUNDING FOR NUMEROUS COUNTYWIDE PROGRAMS THAT THE COUNTY EXECUTIVE COMMITTED TO FUNDING TO THE FIVE TOWNS INCLUDING, BUT NOT LIMITED TO**

- 1. THE COUNTYWIDE MOSQUITO CONTROL PROGRAM, WHICH NOW HAS BEEN PARTIALLY REIMBURSED WITH THE EXCEPTION OF RETENTION BASINS IN THE TOWNS;**
- 2. THE BOARD OF ELECTIONS COSTS; AND**
- 3. THE COUNTY-OWNED ANIMAL SHELTER**

**AND**

**WHEREAS, THE COUNTY EXECUTIVE HAS INCREASED ITS FEES TO THE TOWN IN THE FORM OF DAY CAMP FEES, POOL INSPECTION FEES, CONCESSION INSPECTION FEES, DUMP TRUCK FEES WITH NO EXPLANATION AS TO WHY THESE FEES NEEDED TO BE INCREASED, AND**

**WHEREAS, THE TOWNS CANNOT, AND SHOULD NOT, ASSUME THESE COSTS BASED UPON AN AGREEMENT THAT THE COUNTY EXECUTIVE MADE WITH THE TOWNS AND WAS PASSED IN PREVIOUS BUDGETS, AND**

**WHEREAS, IT IS POSSIBLE THAT IF THE COUNTY FAILS TO GET ALBANY TO ALLOW A SALES TAX INCREASE, THE COUNTY COULD CUT THE NARCOTICS/INTEL PROGRAMS AND ANY OTHER BUDGET ITEMS IT IS LEGALLY ENTITLED TO CUT, SO THE CONTINUATION OF THIS AND OTHER PROGRAMS ARE IN DOUBT FOR 2013, AND**
