**PUBLIC PARTICIPATION**

Lou Morris, 23 Richard Court, Pomona, NY was concerned about where the traffic from Legoland would go.

Supervisor Phillips stated that Legoland would have to do a traffic study, SEQR and an Environmental Impact Statement. The State must step up and do drastic improvements.

Gil Musinger, 1416 Round Pointe Drive, Haverstraw, NY is concerned about the speed signs on Short Clove Road. In June there was a serious accident. A lot of confusion still exists because there are two speed signs, one that says 15 MPH and once that says 25 MPH.

Supervisor Phillips stated that we wrote to the New York State Department of Transportation and the Village of Haverstraw . We haven't received a response. We will write to them again.

Mel Post, 1422 Round Pointe Drive, Haverstraw, NY stated that the Village of Haverstraw and the Town of Haverstraw held a meeting on the same evening several weeks ago. Could we see that in the future we don't do this and also not hold them on religious holidays.

Supervisor Phillips said that we will take a look at that. We only hold one meeting in the months of July and August.
