RESOLUTION TO DECLARE LEAD AGENCY

Councilman Cancel offered the following resolution, which was seconded by Councilman Gould, and on roll call unanimously adopted.

for determining whether an environmental impact statement is required in connection with the action, and for the preparation and filing of the statement if one is required", and;

WHEREAS the Town of Haverstraw intends to act as Lead Agency in the coordinated review of said Actions as Unlisted Action under SEQRA and further intends to implement and complete all responsibilities of that office,

Therefore, be it

RESOLVED that the Town of Haverstraw Town Board declares itself Lead Agency, as defined in 6NYCRR Part 617.2(u), for the coordinated review of said Actions as Unlisted Actions under SEQRA.

A RESOLUTION TO ADOPT A NEGATIVE DECLARATION UNDER STATE ENVIRONMENTAL QUALITY REVIEW ACT (SEQRA) FOR PROPOSED DOG PARK IN HAVERSTRAW, NY

Councilman Soto offered the following resolution, which was seconded by Councilman Gould, and on roll call unanimously adopted.

- **WHEREAS**, The Town of Haverstraw proposes to construct a recreational dog park (hereafter referred to as, "proposed action") including:

WHEREAS said proposed action is an Unlisted Action under 6NYCRR Part 617 because the action is not listed under 6NYCRR Part 617.4 or 617.5.

WHEREAS, the Town of Haverstraw Board (hereafter, "the Board"), having approval authority over the proposed action, duly declared itself lead agency on _____ for a coordinated review among multiple authorizing agencies per 6NYCRR Part 617.6(b)(2)(i), and has received no objection to this declaration from other agencies within 30 days, and

WHEREAS, the Board, as lead agency, must make a determination of significance of the proposed action per 6NYCRR Part 617.7, and

WHEREAS, the Board has considered the proposed action as defined in 6NYCRR Part 617.2(b) and 617.3(g), and

WHEREAS, the Board has reviewed Parts 1, 2, and 3 of a Full Environmental Assessment Form prepared for the proposed action under criteria outlined in 6NYCRR Part 617.7(c), and

WHEREAS, the Board finds that the proposed work will not result in significant adverse environmental impacts to:

- Land
- Water
- Air
- Plants and Animals
- Agricultural Resources
- Aesthetic Resource
- Cultural or Archeological Resources
- Open Space
- Critical Environmental Areas
- Transportation
- Energy
- Noise or Odor

WHEREAS, the Board finds, based on the criteria outlined in 6NYCRR Part 617.7(c), that the proposed action will <u>not</u> have a significant adverse impact on the environment for the following reasons:

- The proposed action is not located within a state-regulated viewshed.
- The proposed action will not impact local traffic or adversely affect public health or community character.

Therefore, be it

RESOLVED that the Board shall adopt in its determination of significance under 6NYCRR Part 617.7, this *NEGATIVE DECLARATION*, indicating that information provided in the Full Environmental Assessment Form attached hereto has sufficiently demonstrated that the proposed action will not result in significant adverse environmental impacts, and that an Environmental Impact Statement need not be prepared.

AGREEMENT BETWEEN THE TOWN OF HAVERSTRAW AND VALUATION PLUS, INC.

Councilman Cancel offered the following resolution, which was seconded by Councilman Soto, and on roll call unanimously adopted.

OF MAMARONECK, NEW YORK TO PERFORM AN APPRAISAL FOR THE GARNERVILLE ARTS CENTER IN GARNERVILLE, NY AT A COST OF \$5,000.00.

PUBLIC PARTICIPATION

Five residents asked Supervisor Phillips and the Town Board about the status of the Legoland proposal.

<u>Supervisor Phillips</u> explained that it was unfortunate that someone sent out a flyer and posted misinformation on social media about the Legoland proposal. The Town Board is still investigating and receiving comments and no decisions have been made. It has always been the intention of the Town Board to hold public meetings to listen to the concerns and questions of the residents and citizens of Rockland County. Legoland would also have a presentation so that all of our residents could ask questions and have their concerns addressed.

The Supervisor further stated that if they proceed after that, there will be numerous public meetings and public hearings that are required by law under the New York State Environmental Quality Review Act (SEQRA). It would give the public additional opportunities to ensure their concerns are addressed.

<u>Supervisor Phillips</u> concluded by saying that there is no agreement and no decision has been reached. We still would like to go and view the Legoland in California and after that have the public come in and voice their opinions.
