**TERMINATION OF GML 207-C BENEFITS FOR EMPLOYEE NO. SYS-016673**

**The following resolution was approved by the full Town Board members and Police Commission.**

**172-16** WHEREAS, a hearing was requested pursuant to the Town of Haverstraw Police Department Line of Duty Injury Procedure relating to Employee No. SYS-016673; and

WHEREAS, hearings were held before the Honorable Alfred Cava, the independent hearing officer selected to hear the matter; and

WHEREAS, the hearing officer heard testimony and took evidence on the question(s) before him, has rendered a decision and forwarded a complete copy of the record, together with his findings of fact and recommendation to the Town Board for its consideration; and

WHEREAS, the Town Board has reviewed the record together with the findings of fact and recommendations of the hearing officer;

**NOW, THEREFORE, BE IT RESOLVED** that the Town Board of the Town of Haverstraw and the Police Commission, hereby non-concurs and disagrees with the following findings of fact and recommendations of the hearing officer in his decision dated December 29, 2015, which found (i) that Employee No. SYS-016673 was unable to perform the full duties of his position due to a causally related injury arising out of a claimed injury on July 25, 2013; (ii) that the narcotic pain medication, which Employee No. SYS-016673 admitted that he had been using prior to the claimed injury of July 25, 2013, was causally related to the claimed injury on July 25, 2013; (iii) that use of said narcotic pain medication disabled Employee No. . SYS-016673 from performing the full duties of his position; (iv) that the Town's medical consultant, Dr. Warren Silverman, did not have sufficient information to provide conclusive opinions on causal relationship and fitness for duty; and (v) that the return to work order of the Police Chief dated April 8, 2015 was not supported by substantial evidence; and

**BE IT FURTHER RESOLVED** that the Town Board of the Town of Haverstraw, and the Police Commission, finds that a claimed "cervical strain/cervical radiculopathy" condition was the only injury accepted by the Town of Haverstraw under General Municipal Law Section 207-c arising out of the claimed injury of July 25, 2013 and that the Town of Haverstraw never accepted claimed injuries with respect to the right knee or carpal tunnel syndrome; and

**BE IT FURTHER RESOLVED** that the Town Board of the Town of Haverstraw, and the Police Commission, finds that Employee No. SYS-016673 was not disabled from performing his full duties as a police officer as ordered by the Chief of Police, a finding based on a review of the entire record, including the physical condition and pre-existing injuries of Employee No. SYS-016673 prior to the claimed injury of July 25, 2013; said Employee's use of narcotic pain medication prior to the claimed injury of July 25, 2013; said Employee's admitted physical activities after the claimed injury of July 25, 2013; and the medical examination of said



Employee by Dr. Warren Silverman as well as his review of medical records, his written report and his sworn testimony; and

Noel Rappaport, Lewis Drive, Garnerville, NY, asked if the Town has considered having a taxi commission to regulate the taxicabs in the Town.

Supervisor Phillips stated that the Town has considered it. However, we were hoping for the County to adopt a taxi code because of the fact that taxicabs cross over so many municipal lines. If the County adopts, it would be uniform throughout the County, but if the Town does it, it would only be good within the unincorporated area of the Town and not the Villages of Haverstraw, West Haverstraw and Pomona. Supervisor Phillips asked Legislator Jay Hood, who was present at the meeting, if there is any movement on the County level about a taxi code.

Legislator Jay Hood, Jr. stated that just last week he received a draft law from the County Executive's office. The County Legislature is reviewing it. The law won't cover everything that every village wants; it's going to be a general code for licensing and things like that. As far as parking, the Villages will have to do that themselves.
