Supervisor Phillips announced that this is a continuation of a Public Hearing that was being held to consider adopting a local law amending the Town Code of the Town of Haverstraw, Chapter 167 entitled, "ZONING" Article XX, entitled, "GATHERING PLACES."

The Town Clerk read proof of publication and presented the Affidavit of Publication to the Board.

**PRESENTATION BY STEVE SILVERBERG, PLANNING AND ZONING CONSULTING ATTORNEY AND WILLIAM M. STEIN, TOWN ATTORNEY**

Steve Silverberg, Consulting Attorney stated that he, along with William Stein, Town Attorney, and Michael Kauker, Planning and Zoning Consultant, are still reviewing and considering the substantial amount of input they have received from the residents and the Town Board after the first Public Hearing was held. Some revisions to the proposed law have been made, taking into consideration the feedback they received. There was a posting on the Town's website indicating that this Public Hearing will be continued and that a decision would not be made at tonight's meeting. A revision of the law will be available for everyone's perusal on the Town website in a few more weeks. In the meantime the Town will continue to accept feedback, comments or concerns from the public.

William M. Stein, Town Attorney stated that the Public Hearing will remain open and continue at the Town Board Meeting of June 26, 2017 at 8:05 p.m. A legal notice will be published confirming the change.

**PUBLIC PARTICIPATION**

Paul McCallister, 20 Lea Court, Garnerville, NY asked if the ordinance that the Town is proposing will be retroactive, and if not are there any grandfathering implications concerning that.

Steve Silverberg, Consulting Attorney stated that the proposed law is going to be a Zoning Law and that grandfathering of existing gathering places without approvals will not be permitted. Anyone currently operating a non-permitted gathering place in a residential single family home will be required to file for special permit approval and meet certain criteria outlined in the law.

**WHEREAS, THE TWO YOUNG MEN WHO COMMITTED THIS HEINOUS CRIME AFTER A DAY SPENT DRINKING IN A LOCAL BAR RECEIVED THE MAXIMUM PENALTY FOR MURDER THAN ALLOWED IN NEW YORK STATE, TWENTY-FIVE YEARS TO LIFE IN PRISON; AND**

**WHEREAS, PAULA'S FAMILY AND FRIENDS, AS WELL AS THOSE LIVING IN ROCKLAND COUNTY AT THE TIME, CAN STILL RECALL THE HORROR OF THAT DAY; AND**

**PUBLIC PARTICIPATION**

Karen Boucher, 47 Phyllis Drive, Pomona, NY asked why the Town of Haverstraw doesn't enact fines for predatory realtors like other municipalities do.

Supervisor Phillips stated that we have been enacting fines. It has been in existence in our Town Code for many years that for anybody to knock on somebody's door to solicit, they are required to have a hawking and peddling license. On our last Town Board meeting, we passed a law amending the existing law to increase the fines and also to add a "Do Not Knock Registry." Any owner or occupant of a residence requesting to be enrolled on the "Do Not Knock Registry" may also obtain from the Town Clerk a decal for display at their premises, reflecting their enrollment on the "Do Not Knock Registry". Someone who has a license to solicit is responsible to review who is on the list. If they solicit someone who is on the list, they will be subject to hefty fines and possibly revocation of their license and or/ jail time if they continue to violate the law.

Mary Meehan, 7 Poplar Road, Garnerville, NY stated that school bus #429 parks every single morning on the street between the Ramapo driveway and the driveway of the first house on Balsam Road, making the street narrower and unsafe for others.

Supervisor Phillips stated that we will notify the bus company about this situation and ask them to park somewhere else since parking there narrows the road and confines your ability to get through.
