**PRESENTATION BY TOWN ATTORNEY WILLIAM M. STEIN**

William M. Stein, Town Attorney stated that the Town received feedback from the public on the issue of noise ordinance and exemptions. One of the issues that residents felt that was necessary was to reduce the time of which sound reproduction devices and or musical instruments used in connection with weddings, celebrations or similar events on any property used for residential purposes could go on. The old code provision provided for 12:30 am on Saturdays and Sundays and 11:00 pm on the weekdays. This proposed new Local Law pushes each of those back from 11 pm to 10 pm on Monday, Tuesday, Wednesday and Thursday nights and from 12:30 am to 11:30 pm on Friday, Saturday and Sunday nights. Also, based on the recommendation of Building Inspector George Behn the proposed Local Law states that sound levels in excess of those permitted in § 114-5A and § 114-5B are allowed, provided that such sound levels are not plainly audible at a distance of 50 feet from the place, building, structure or vehicle in which it is located.
