The Town Board of the Town of Haverstraw held a Public Hearing on Tuesday, December 13, 2022 at 7:05 p.m. in the Meeting Room of the Town Hall, One Rosman Road, Garnerville, New York.

Supervisor Phillips announced that this Public Hearing is being held to consider adopting Local Law No. 3-2022, to amend Chapter 158 Article III of the Town Code of the Town of Haverstraw, Entitled "Vehicles and Traffic", Section 158-19, "Parking, Standing and Stopping."

The Town Clerk read proof of publication and presented the affidavit of publication to the Board.

PRESENTATION BY WILLIAM M. STEIN, TOWN ATTORNEY

William M. Stein, Town Attorney stated that the intent of the local law is to amend Chapter 158 Article III of the Town Code of the Town of Haverstraw to read: "All-night parking on any of the streets, roads and highways of the Town is prohibited during the period from November 15 to April 1. "All-night parking" is hereby defined as parking between 12:00 am and 6:00 am." Prior to the amendment, the hours were from 2 am to 6 am therefore extending it by two hours. Superintendent of Highways George Wargo, Jr. recommended this revision.
