RESOLUTION - BOY SCOUTS OF AMERICA DAY 100 YEARS OF SCOUTING

Councilman Cancel offered the following resolution, which was seconded by Councilman Gould, and on roll call unanimously adopted.

140-10 WHEREAS, THE BOY SCOUTS OF AMERICA, A VOLUNTEER ORGANIZATION, WAS INCORPORATED BY CHICAGO PUBLISHER WILLIAM D. BOYCE ON FEBRUARY 8, 1910, AFTER LEARNING OF THE SCOUTING MOVEMENT DURING A VISIT TO LONDON; AND

WHEREAS, ON JUNE 21, 1910, A GROUP OF 34 NATIONAL REPRESENTATIVES MET, DEVELOPED ORGANIZATION PLANS, AND OPENED A TEMPORARY NATIONAL HEADQUARTERS IN NEW YORK; AND

WHEREAS, THE PURPOSE OF THE BOY SCOUTS OF AMERICA IS TO TEACH AMERICA'S YOUTH PATRIOTISM, COURAGE, SELF-RELIANCE, AND KINDRED VALUES; AND

WHEREAS, THE BOY SCOUTS OF AMERICA HAS AND CONTINUES TO LIVE OUT ITS COMMITMENT TO HELPING MILLIONS OF YOUTH SUCCEED BY PROVIDING THE SUPPORT, FRIENDSHIP, AND MENTORING NECESSARY TO LIVE A HAPPY AND FULFILLING LIFE; AND

WHEREAS, BY 1912, BOY SCOUTS WERE ENROLLED IN EVERY STATE; AND

WHEREAS, IN 1961, THE UNITED STATES CONGRESS GRANTED THE BOY SCOUTS OF AMERICA A FEDERAL CHARTER; AND

WHEREAS, EACH COUNCIL COMMITS EACH SCOUT TO PERFORM AT LEAST 12 HOURS OF COMMUNITY SERVICE YEARLY, TOTALING MORE THAN 30,000,000 COMMUNITY SERVICE HOURS EACH YEAR; AND

WHEREAS, THERE HAVE NOW BEEN MORE THAN 111,000,000 MEMBERS OF SCOUTING, AND THE ORGANIZATION WILL PRESENT THE 2 MILLIONTH EAGLE SCOUT AWARD IN 2009; AND

WHEREAS, MORE THAN 1 MILLION ADULT VOLUNTEER LEADERS SELFLESSLY SERVE YOUNG PEOPLE IN THEIR COMMUNITIES THROUGH ORGANIZATIONS CHARTERED BY THE BOY SCOUTS OF AMERICA; AND

WHEREAS, THESE MEN AND WOMEN OFTEN NEITHER RECEIVE NOR SEEK THE THANKS OF THE PUBLIC; AND

WHEREAS, FEBRUARY 8, 2010, WOULD BE AN APPROPRIATE DAY TO DESIGNATE AS "BOY SCOUTS OF AMERICA DAY" IN CELEBRATION OF THE BSA's 100^{TH} ANNIVERSARY; AND

WHEREAS, THE BOY SCOUTS OF AMERICA ENDEAVORS TO DEVELOP UNITED STATES CITIZENS WHO ARE PHYSICALLY, MENTALLY, AND EMOTIONALLY FIT; HAVE A HIGH DEGREE OF SELF-RELIANCE AS EVIDENCED IN SUCH QUALITIES AS INITIATIVE, COURAGE, AND RESOURCEFULNESS; HAVE PERSONAL VALUES BASED ON RELIGIOUS CONCEPTS; HAVE THE DESIRE AND SKILLS TO HELP OTHERS AND UNDERSTAND THE PRINCIPLES OF THE UNITED STATES SOCIAL, ECONOMIC, AND GOVERNMENTAL SYSTEMS; TAKE PRIDE IN THEIR AMERICAN HERITAGE AND UNDERSTAND OUR NATION'S ROLE IN THE WORLD; HAVE A KEEN RESPECT FOR THE BASIC RIGHTS OF ALL PEOPLE, AND ARE PREPARED TO PARTICIPATE IN AND GIVE LEADERSHIP TO THE AMERICAN SOCIETY; NOW, THEREFORE, BE IT

Mr. Greco stated that it is also time for him to pass the baton on to someone else and that on behalf of the Road Runners would like to thank Supervisor Howard Phillips, Town Board members and Mike Cotier, Park Director for their support throughout the years.

<u>Sandra Bullock, Thiells</u> stated that she is a resident of the Town of Haverstraw and that this is her second board meeting. Why was no information given after the resolutions were passed? It was done in record time.

<u>Supervisor Phillips</u> stated that we have moving a little faster tonight because of the first Annual Heart of Haverstraw Award presentation. However, we reserve the public participation time for any questions, comments or statements that the public may have. When a budget line expenditure exceeds their original budget within a certain Fund, transfers are made from other budget lines within the same Fund that have not exceeded their original budget.

<u>Supervisor Phillips</u> stated that we are extremely proud of our audit and received no comments about our accounting system.

Al Arlitz, 17 Hillside Drive, Thiells asked why the Journal News does not put a summary of the Town Board meetings in the paper anymore or make announcements if something is going on in the Town.
