Mr. Silverberg stated that this Local Law is to amend Chapter 167 of the Town Code to create a special permit use called Country Commercial Development to allow environmentally appropriate local small businesses to exist in a mixed-use zoning serving local neighborhoods. Please see Local Law No. 2-2011.

### RESOLUTION ADOPTING PROPOSED LOCAL LAW NO. 2 OF 2011 AMENDING THE TOWN ZONING CODE

On motion by Councilman Soto, seconded by Councilman Cancel, unanimously adopted, the Public Hearing was closed.

236-11 RESOLVED, that the Town Board declares itself lead agency pursuant to the State Environmental Quality Review Act (SEQRA) and finds this to be a TYPE I action under SEQRA, and be it further

RESOLVED, that the Town Board hereby adopts the annexed SEQRA Negative Declaration finding that the proposed amendment requires no further environmental review, and this notice has been prepared in accordance with Article 8 (State Environmental Quality Review Act) of the New York State Environmental Conservation Law, and be it further

RESOLVED, that the Town Board of the Town of Haverstraw, as lead agency, has determined that the proposed action described below will not have a significant effect on the environment and a Draft Environmental Impact Statement will not be prepared:

**Description:** The proposed action consists of the consideration and adoption of a proposed local law, which would amend the zoning ordinance by creating a new zoning district called the Country Commercial Business District, which would allow by special permit a single or two story attached retail or service retail businesses which is limited to include a: bakery, barber shop, convenience store, china and giftware store, clothing store, deli, florist, floral decorating, hair salon, jewelry store, picture framing, pharmacy, sporting goods, furniture, shoe, health care and beauty aids and video rental stores. The structure may also include a single accessory apartment above the first-floor commercial use.

Location:

Town of Haverstraw, Rockland County, New York. Along fully improved State or County roads in all zoning districts except the R-40 and R-120 Districts

### **Reasons Supporting This Determination:**

- 1. The proposed zoning amendment, which would permit as by a special permit the uses identified above in every zoning district, except the R-40 and R-120 districts, in the Town of Haverstraw, is not anticipated to result in any adverse environmental impacts for the following reasons.
- 2. The proposed action is not site specific and is generic in nature and the amendment of the ordinance does not actually result in the actual development of a site but permits the development of a site to occur for the uses identified above. Therefore, it is not anticipated that the change in zoning would result in a substantial impact on the environment.
- 3. Any potential impacts resulting from the proposed use would only be realized when a specific site is developed. It is anticipated that a separate environmental review will be performed and that all of the potential impacts related to the development of a site for a will be fully reviewed when a specific application is made.
- The Town of Haverstraw has also adopted appropriate controls in order to regulate the 4. size, setbacks and other requirements related to the construction of the uses identified above which will adequately help to mitigate any potential impacts that may result from the development of said use.
- It is not anticipated that any of the criteria as described in §617.7(c)(1)(i -xii) would be 5. significantly impacted as a result of the zone change, and

BE IT FURTHER RESOLVED, that for the foregoing reasons the Town Board hereby adopts Local Law No. 2 of 2011 as amended.

### LOCAL LAW NO. 2 OF 2011

# A LOCAL LAW OF THE TOWN OF HAVERSTRAW AMENDING CHAPTER 167 OF THE CODE OF THE TOWN OF HAVERSTRAW BY ADDING A COUNTRY COMMERCIAL BUSINESS DISTRICT

**Be it enacted** by the Town Board of the Town of Haverstraw as follows:

#### **SECTION 1. Purpose:**

The purpose of this local law is to create a special permit use called Country Commercial Development to allow environmentally appropriate local small businesses to exist in a mixed-use zoning serving local neighborhoods.

### **SECTION 2.** Amendment to Chapter 167

Chapter 167 (Zoning) of the Haverstraw Code is amended by adding to Section 167-3 (Word Usage and Definitions) the following definitions in appropriate alphabetical order:

COUNTRY COMMERCIAL:

A. A single or two story attached retail or service retail businesses which is limited to include a: bakery, barber shop, convenience store, china and giftware store, clothing store, deli, florist, floral decorating, hair salon, jewelry store, picture framing, pharmacy, sporting goods, furniture, shoe, health care and beauty aids and video rental stores.

#### **SECTION 3.** Country Commercial Uses

Chapter 167 (Zoning) of the Haverstraw Code is amended to create a new Section 167-37.3, to read as follows:

- a. A Country Commercial Use as designated by special permit issued by the
   Town Board subject to the following restrictions:
  - Permitted in all zoning districts with the exception of the R-120 and R-40 Districts.
  - 2. Any such business establishment must have frontage on a fully improved state or county road.
  - 3. The minimum lot area required for a use permitted in this section shall be 17,500 square feet.
  - 4. If not specifically regulated in this section, the proposed use shall comply with all other applicable bulk requirements of the underlying zoning district in which the property is located, as contained in the Table of General Bulk Requirements.

- 5. The principal structure shall not exceed 2000 square feet of building area (inclusive of finished and unfinished interiors) and may include a single accessory apartment above the first-floor commercial use, provided that this single accessory use has a valid certificate of occupancy, does not exceed 900 square feet and is otherwise permitted use in the Zoning District where the parcel of land is located.
- 6. The accessory apartment is required to have a minimum of 2 parking spaces and the retail establishment is required to have a minimum of 4 parking spaces per 1,000 square feet of gross floor area (GFA), with at least one handicapped parking space included among the required spaces. Specifically, the dimensions of the at grade parking spaces shall be for each standard space (18 feet length, 9 feet width and 24 feet aisle width) and for each handicapped space (18 feet length, 9 feet width and 8 feet access aisle width).
- 7. All parking areas shall be suitably screened and buffered as determined by the Planning Board during site plan review.
- 8. The use must be both environmentally appropriate and compatible with a low density, suburban or rural residential environment as determined in the sole discretion of the Town Board.
- 9. The building shall be designed so that it appears residential in nature and is compatible with existing residential structures in the area.
- 10. All buildings are required to have a pitched roof and flat roofs are not permitted.
- 11. All uses permitted under this section shall be referred to the Architectural Review Board.
- b. In addition to the particular requirements for such use (as delineated at subdivision a above) as determined in their sole discretion the Planning Board as part of a site plan review may require sight easements, fences, safety devices, landscaping, screening, access roads and or buffer areas to the adjacent neighboring area.

### **SECTION 4. Severability**

The invalidity of any word, section, clause, paragraph, sentence, part or provision of this local law shall not affect the validity of any other part of this local law that can be given effect without such invalid parts or parts.

### **SECTION 5.** Effective Date

This Local Law shall take effect immediately upon its adoption and filing with the Secretary of State.

### **PUBLIC PARTICIPATION**

<u>Lynn Teger, 5 Simenovsky Drive, Haverstraw, NY</u> stated that she called regarding the workshop and was told that there was no workshop today.

<u>Supervisor Phillips</u> stated that we cancelled tonight's workshop because we didn't have anything on for workshop. You tell people that we don't have scheduled workshop meetings. The reason you're not familiar with workshop meetings is the fact that you have never come before to our workshop or Town Board meetings.

Lynn Teger, 5 Simenovsky Drive, Haverstraw, NY stated that she never told anyone that you don't have scheduled workshop meetings. What I said is that when I went to the one workshop meeting, the first one, and that was at 7:00 PM I was told that the workshop meeting was from 7:00 PM to 8:00 PM. The week after I called and asked what time the meeting was. It took three girls to ask when the workshop was. I was told if you want to know, come in and find out yourself. No workshops are on the web site.

Supervisor Phillips stated that I read your blog. I would like to review it with you.

<u>Lynn Teger, 5 Simenovsky Drive, Haverstraw, NY</u> stated I just wanted to know about the workshop.

<u>Supervisor Phillips</u> stated that the workshop is at 6:00 PM on Town Board Meeting nights, if there is material to discuss. If there is nothing to discuss, there is no workshop. We have had workshops since 1983. You also referred on your blog that we spoke about unimportant matters at workshop.

<u>Supervisor Phillips</u> stated that I can assure you that any time we have a discussion that involves using taxpayers' funds, it is important or using the Police Department it is important, or any Town function that the public is attending it is important. You blogged that what we discussed is unimportant.

Lynn Teger, 5 Simenovsky Drive, Haverstraw, NY stated I came to a Town meeting and waited 45 minutes to discuss road paving and fireworks. I will be recording the meetings. I don't have to tell you every time. At the last school budget meeting the reserve is still on the table. Have there been any discussions since then?

<u>Supervisor Phillips</u> stated I do not believe in using additional reserves. When we reviewed the financial report it showed that they used \$647,000 out of the \$15 million dollars in reserves year ending June 30, 2010. You have to budget more closely. The only way to build up reserves is to over budget expenditures and underestimate revenue. To continue to use reserves is a fool's game. Budget expenses and estimate revenues more accurately.

<u>Lynn Teger, 5 Simenovsky Drive, Haverstraw, NY</u> stated that your recommendation is not to use any more reserves?

<u>Supervisor Phillips</u> stated that you have to estimate expenditures and revenues accurately.

<u>Lynn Teger, 5 Simenovsky Drive, Haverstraw, NY</u> stated that at the last school board meeting Debbie Gatty said that the issue of reserves is still on the table.

<u>Supervisor Phillips</u> stated to go from \$42 million dollars to \$84 million dollars how did you get there in five years? The only way is by overestimating expenditures or underestimating revenues or both. You have to stop overestimating expenditures and underestimating revenue.

<u>Lynn Teger, 5 Simenovsky Drive, Haverstraw, NY</u> stated that it should be budgeted instead of dipping into reserves.

The 4<sup>th</sup> of July Fireworks Celebration is scheduled for July 2<sup>nd</sup> with a rain date of July 3<sup>rd</sup>.

The Youth Board had a boat trip yesterday. It was a nice trip and well attended. A lot of the kids from the Villages attended.

The 3-mile run went well. We will be able to give approximately \$9,000.00 to each of the families.

The boaters at the Haverstraw Marina are amazed at what we have to offer to the public.
