PUBLIC PARTICIPATION

Steve Harris, Pomona, NY stated that he attended the legislative meeting regarding the safety of Thiells Mt.-Ivy Road such as installing new lighting on every pole on the wide open stretch. Why can't lights be put up on the poles? Mr. Harris had another issue concerning guard rails on Beach Road. He stated that the guard rails were missing and it is a very dangerous spot. Can the Town Board please look into this matter? Mr. Harris, Anthony's family and several residents inquired about naming Thiells Mt.- Ivy Road after Anthony Amoros.

Supervisor Phillips stated that we would take a look at the lighting on Thiells Mt.- Ivy Road. The lighting has not been updated but I don't think the lighting had anything to do with the accident. I believe it was the condition of the road. When I was a County Legislator, I asked that Thiells Mt.- Ivy Road be setup as a capital project. It was up to the County Executive to fund the project and he never did that. Over the years, I sent several letters to the County Highway Dept. regarding this. We researched for grants that applied to county roads but the county did not apply for them. As a town, we applied for a 2 million dollar grant, which we were not awarded. The road is old and narrow in some spots. It is also too dangerous along Rosman Rd. and Ridge Rd. The county was to put a snow fence along Ridge Rd and never did so the town did to keep the snow from blowing on Thiells Mt.- Ivy Road. The county said they had no money left in the budget. They could easily apply for grants and have the road bonded. There is not enough shoulder and not enough width on parts of the road. The road needs to be improved. We can look at the lighting; it's the condition of the road that really matters. We need to get a traffic person out there.

The supervisor further stated that Beach Rd. is a county road. We spoke to the county executive staff right after Hurricane Sandy regarding that section of the road because it was washed away and it was not open. The county tried to address it, but I am sure they are waiting for federal money. As far as renaming the road, I am sure that we would not have a problem with it. I do not know what the procedure is, but I will look into that.

Matt Morino stated that there are many issues that need to be addressed on that road. Maybe more police presence on Thiells Mt. - Ivy Rd is needed. We just want to prevent anything from happening. By educating people, it would really make a difference.

Supervisor Phillips stated well-spoken and we really appreciate your comments. We need the county to install concrete curbs and other safety measures such as a guard rail along that area. I hope you get a quick response and keep pressuring the county.

<u>Ilan Schulein, Hillside Drive, Thiells</u> stated that he supports the safety of Thiells Mt.-Ivy Road and has brought this issue to the Town Board.

Mr. Gonzales, New Jersey asked who has control over making the curbs, widening the roads and installing better lighting.

Supervisor Phillips stated that it is the county, but we will definitely take a look at it.

Mr. Gonzales, New Jersey stated that Jay Hood Jr., County Legislator, who was at the legislative meeting, said that he takes his job very seriously and it matters to him that he was concerned.

<u>Supervisor Phillips</u> stated that we really take this seriously. More shoulder, road widening, and site distance are just some of the issues that need to be addressed by the county.

Mel Post, 1422 Roundpointe Drive, Haverstraw, NY stated that the school budget vote and the library vote that are in September are held a couple of weeks apart. Why can't they be on the same day or at the same place? Is there a cost savings involved in doing that?

<u>Supervisor Phillips</u> suggested Mr. Post write a letter to the library and school boards and to please give him a copy. It's something we talked about and it should be one election. The library would have to enact it - we have no control over that.

Mel Post, 1422 Roundpointe Drive. Haverstraw, NY stated that on occasion the Town Board Meetings and the Village Board Meetings are on the same date. We like to go to both meetings. Could we get some cooperation in order to make that happen?

<u>Supervisor Phillips</u> stated that he will ask the mayor if he would consider moving his meeting dates being that the town already has our dates set.

ANNOUNCEMENTS

<u>Bruce Leach, 22 N. Wayne, West Haverstraw</u> announced that the Hudson Valley Radio Control Club hosted the Warbirds Over the Hudson on Saturday, July 20. It was a great day. The next Annual Air Show will be on August 17th.

<u>Supervisor Phillips</u> stated that we had to cancel three Thursday night open air concerts due to rain. So we will hold them on Sunday afternoon.

The Supervisor would like to compliment Councilmen Soto and Cancel for organizing the Latino parade in the Village of Haverstraw. It was a great day with no rain.
