WHEREAS 6NYCRR Part 617.6(b)(3) calls for coordinated review of Type I Actions, and:

**WHEREAS** 6NYCRR Part 617.6(b)(2)(i) requires that a Lead Agency for a coordinated review of an Type I Action be established prior to a determination of significance, and;

**WHEREAS** 6NYCRR Part 617.2(u) defines "Lead Agency" as, "an involved agency principally responsible for undertaking funding or approving an action, and therefore responsible for determining whether an environmental impact statement is required in connection with the action, and for the preparation and filing of the statement if one is required", and;

**WHEREAS** the Town of Haverstraw intends to act as Lead Agency in the coordinated review of said Actions as Type I Action under SEQRA and further intends to implement and complete all responsibilities of that office,

Therefore, be it

**RESOLVED** that the Town of Haverstraw Town Board declares itself Lead Agency, as defined in 6NYCRR Part 617.2(u), for the coordinated review of said Actions as Type I Actions under SEQRA.
