## RESOLUTION ADOPTING PROPOSED LOCAL LAW NO. 8 OF 2018 AMENDING THE TOWN ZONING CODE

411-18 WHEREAS, it has come to the attention of the Town Board that certain bulk regulations relating to assisted living facilities are inconsistent with reasonable development of larger parcels of property, and

WHEREAS, the Town Board believed it would be beneficial to develop new regulations for parcels that are 4.5 acres or larger, and

WHEREAS, the Town Board requested that its planning consultant recommend language to be incorporated into a local law that would more realistically address appropriate bulk requirements for such parcels, and

WHEREAS, a proposed local law creating a new section 167-67.3 was circulated in accordance with General Municipal Law (GML), and

WHEREAS, the Town Board has held a duly noticed public hearing on the proposed Local Law to receive comments on the proposed text of the Local Law, and

WHEREAS, the GML notices were circulated more that thirty days prior to the date this resolution was adopted and no negative comments were received by the date of the adoption of this resolution

#### NOW THEREFORE,

BE IT RESOLVED, that the Town Board hereby adopts the annexed SEQRA Negative Declaration finding that the proposed amendment requires no further environmental review, and

BE IT FURTHER RESOLVED, that for the foregoing reasons the Town Board hereby adopts Local Law No. 8 of 2018.
