WHEREAS, AT ALL RELEVANT TIMES THE ZONING DESIGNATION FOR THE **PREMISES** WAS "NEIGHBORHOOD SHOPPING". **INSTRUMENT** WHEREAS, \mathbf{BY} **ENTITLED** "DECLARATION ESTABLISHMENT OF RESTRICTIVE COVENANTS FOR REAL PROPERTY", RECORDED IN THE OFFICE OF THE ROCKLAND COUNTY CLERK ON DECEMBER 27, 1985 IN BOOK 0126, PAGE 0805 (THE "RESTRICTIVE COVENANT"), THE OWNERS DECLARED AND COVENANTED THAT THE PREMISES "SHALL BE USED FOR PROFESSIONAL OFFICE USE ONLY AND SHALL NOT BE USED FOR ANY OTHER OF THE OTHER DESIGNATED USES PERMITTED BY THIS ZONE".

WHEREAS, THE RESTRICTIVE COVENANT FURTHER PROVIDED THAT "THE SAID RESTRICTIVE COVENANT SHALL CEASE TO APPLY ONLY UPON THE CONSENT AND APPROVAL OF THE TOWN OF HAVERSTRAW (THE "TOWN").

WHEREAS, IN 2017 THE TOWN ADOPTED LOCAL LAW NO. 4 OF 2017 ("LOCAL LAW NO. 4") CREATING A NEW OVERLAY ZONE ENTITLED "ROUTE 202 FLOATING OVERLAY DISTRICT" TO PROVIDE AND ENCOURAGE GREATER FLEXIBILITY IN FUTURE LAND USES AND FOSTER NEW DEVELOPMENT AND TO ADDRESS A NEED FOR HOUSING OF THE SENIOR POPULATION THROUGH THE CREATION OF A FLOATING ZONE APPLICABLE TO PROPERTIES ALONG ROUTE 202, INCLUDING THE PREMISES, THAT MEET CERTAIN STANDARDS RECITED IN LOCAL LAW NO. 4.

WHEREAS, THE PREMISES, TOGETHER WITH FOUR ADJOINING PROPERTIES, WAS DETERMINED BY A VOTE OF THE TOWN OF HAVERSTRAW TOWN BOARD TO MEET THE NECESSARY MINIMUM REQUIREMENTS FOR INCLUSION IN THE OVERLAY ZONE.

WHEREAS, THE PURPOSE AND UNDERLYING NEED FOR THE RESTRICTIVE COVENANTS ON THE PREMISES NO LONGER EXIST, AND THE RESTRICTIVE COVENANTS WOULD FRUSTRATE THE PURPOSE OF THE OVERLAY ZONE, WOULD PREVENT THE DEVELOPMENT OF THE PREMISES FOR THE SPECIFIC PURPOSES FOR WHICH LOCAL LAW NO. 4 WAS INTENDED TO PROMOTE, AND WOULD UNNECESSARILY BURDEN THE PREMISES WITH NO ATTENDANT BENEFIT TO THE TOWN.

WHEREAS, THE CURRENT OWNERS HAVE FORMALLY REQUESTED THE TOWN TO CONSENT TO THE REMOVAL OF THE RESTRICTIVE COVENANTS TO ALLOW THE PREMISES TO BE USED IN ACCORDANCE WITH THE NEW OVERLAY ZONE.

RESOLVED THAT THE TOWN OF HAVERSTRAW HEREBY APPROVES AND CONSENTS THAT THE RESTRICTIVE COVENANT SHALL CEASE TO APPLY TO THE PREMISES AND ARE HEREBY EXTINGUISHED AGAINST THE PREMISES.

APPROVAL OF CHANGE ORDER NO. 1 FOR CONTRACT WITH ENVIRONMENTAL CONSTRUCTION, INC. FOR THE BOWLINE PARK PLAYGROUND IMPROVEMENTS PROJECT
