Supervisor Phillips announced that this Public Hearing was being held to consider adopting Local Law 3 – 2020 to amend CHAPTER 84 of the Town Code of the Town of Haverstraw, Entitled “FIRE PREVENTION AND BUILDING CONSTRUCTION” to add Subsection 84-27 Entitled, “KEY BOXES.”

The Deputy Town Clerk read the proof of publication.

PRESENTATION BY WILLIAM M. STEIN, TOWN ATTORNEY

William M. Stein, Town Attorney stated that the proposed amendments to the Local Law read as follows:

Section 1.

A. When a structure is protected by an automatic fire alarm system or fire suppression system and access to or within the structure is unduly difficult because of secured openings and where immediate access is necessary for lifesaving or fire-fighting purposes, the Fire Chief for the Jurisdiction Having Authority (AHJ) may require a key box to be installed in an approved location and on the structures deemed necessary by the Fire Chief.

B. The key box shall be of the type approved by the Fire Chief and, in order to maintain uniformity throughout Rockland County, order forms for said key box must be obtained from the Fire Chief for the AHJ.

C. The key box shall contain:

- (1) Keys to locked points of ingress, whether on the interior or exterior of such structures.
- (2) Keys to locked mechanical rooms.
- (3) Keys to locked electrical rooms.
- (4) Keys to elevator controls.
- (5) Keys to other areas as directed by the Fire Chief the layout of the building showing the locations of the above.
- (6) Other information as requested by the Fire Chief.

Section 2 – Enforcement

This chapter shall be enforced by the Building Inspector or Fire Inspector of the Town of Haverstraw and/or such other officials authorized by law.

Section 3 - Penalties for Offenses

Any person who shall fail to comply with a written order of the Building Inspector, Deputy Building Inspector, Firesafety Inspector or the appointed designee, within the time fixed for compliance therewith or who shall violate any of the applicable provisions of this article or any lawful order, notice, directive, permit or certificate of the Building Inspector, Deputy Building Inspector, Firesafety Inspector or the appointed designee, made thereunder shall be punishable by a fine of not exceeding \$350 per day for each day of failure to comply with a written order or violation of the applicable provisions of this article or any lawful order, notice, directive, permit or certificate of the Building Inspector, Deputy Building Inspector, Firesafety Inspector or the appointed designee, made thereunder or imprisonment for a period not to exceed six months, or both.

REAL PROPERTY TAX LAW § 420-A, BUT FAILED TO TIMELY APPLY TO THE TOWN ASSESSOR FOR SUCH EXEMPTION ON OR BEFORE TAXABLE STATUS DATE FOR THE 2017 TOWN TAX ROLL, WHICH ROLL WAS USED TO ASSESS THE TOWN'S 2018 TOWN TAX; AND

WHEREAS, IN THE ABSENCE OF ANY EXEMPTION FROM THE PAYMENT OF TAXES, THE TOWN LEVIED ITS REAL PROPERTY TAX FOR THE SUBJECT

WHEREAS, IGLESIA HAS SINCE SECURED SPECIAL STATE LEGISLATION (LAWS OF 2018 CH. 510) AUTHORIZING THE TOWN ASSESSOR TO ACCEPT AND REVIEW IGLESIA'S LATE APPLICATION FOR EXEMPTION ON THE 2017 ASSESSMENT ROLL AS IF IT HAD BEEN TIMELY FILED PRIOR TO TAXABLE STATUS DATE FOR THAT TAX ASSESSMENT ROLL, AND, THEREAFTER, UPON APPROVAL OF THE TOWN BOARD, TO MAKE APPROPRIATE CORRECTION TO THE SUBJECT ROLL; AND,

WHEREAS, THE SPECIAL STATE LEGISLATION FURTHER PROVIDES THAT:

"IF SUCH EXEMPTION IS GRANTED AND SUCH ORGANIZATION, THEREFORE, SHALL HAVE PAID ANY TAX WITH RESPECT TO THE SUBJECT ROLL, THE APPLICABLE GOVERNING BODY OR TAX DEPARTMENT, MAY IN ITS SOLE DISCRETION, PROVIDE FOR THE REFUND OF THOSE TAXES PAID AND CANCEL THOSE TAXES, FINES, PENALTIES, LIENS OR INTEREST REMAINING UNPAID AND,

WHEREAS, IN ACCORDANCE WITH THE SPECIAL STATE LEGISLATION, THE TOWN ASSESSOR HAS REVIEWED IGLESIA'S APPLICATION FOR EXEMPTION AND HAS CONCLUDED THAT, IF IT HAD BEEN TIMELY FILED, THE REAL PROPERTY EXEMPTION WOULD HAVE BEEN GRANTED, WHEREUPON, IN FURTHERANCE OF A TOWN BOARD RESOLUTION DULY ADOPTED ON MARCH 12, 2018, THE ASSESSOR CORRECTED THE ROLL TO REFLECT THE EXEMPTION; AND

WHEREAS, IGLESIA NOW REQUESTS THAT THE TOWN EXERCISE ITS DISCRETIONARY AUTHORITY UNDER THE SPECIAL STATE LEGISLATION AND CANCEL ITS TOWN TAX OBLIGATION, INCLUSIVE OF INTEREST AND PENALTIES, WHICH WOULD THEN TRIGGER A CORRESPONDING OBLIGATION ON THE PART OF THE TOWN TO REFUND ANY TAX AMOUNT PAID TO THE TOWN BY THE COUNTY OF ROCKLAND; AND
