WHEREAS, THE TOWN HAS PREPARED A FULL ENVIRONMENTAL ASSESSMENT FORM, PART 1; AND

WHEREAS, THE TOWN BOARD HAS CALLED FOR A PUBLIC HEARING TO BE OPENED ON THIS LOCAL LAW ON MARCH 22, 2022; AND
