LOCAL LAW # 11 OF 2023
TO ADD ARTICLE §118-24 TO CHAPTER 118 OF THE TOWN CODE OF THE TOWN OF
HAVERSTRAW ENTITLED, "PARKS."

BE IT ENACTED by the Town Board of the Town of Haverstraw, County of Rockland, State of New York, as follows:

Section 1. Article §118-24 is hereby added to the Code to read as follows:

No smoking or vaping of any substance shall be permitted in any Town Park

Section 2. This local law shall take effect immediately upon filing with the Secretary of State.

LOCAL LAW # 12 OF 2023
TO ADD ARTICLE §118-25 TO CHAPTER 118 OF THE TOWN CODE OF THE TOWN OF
HAVERSTRAW ENTITLED, "PARKS"

BE IT ENACTED by the Town Board of the Town of Haverstraw, County of Rockland, State of
New York, as follows:

Section 1. Article §118-25 is hereby added to the Code to read as follows:

No person shall fly or otherwise operate a drone in any Town Park.

Section 2. This local law shall take effect immediately upon filing with the Secretary of State.
