PHILLIPS, JR, SUPERVISOR OF THE TOWN OF HAVERSTRAW, HEREBY DECLARE A STATE OF EMERGENCY IN THE TOWN OF HAVERSTRAW FOR A PERIOD OF TIME BEGINNING 11:30 AM ON DECEMBER 29, 2023, AND CONTINUING IN EFFECT FOR A PERIOD NOT TO EXCEED THIRTY DAYS.

WHEREAS, PURSUANT TO SECTION 24 OF THE NEW YORK STATE EXECUTIVE LAW, THE SUPERVISOR IS AUTHORIZED, UPON THE OCCURRENCE OF A STATE OF EMERGENCY, TO FIND THAT THE STATE OF EMERGENCY EXISTS IN ACCORDANCE WITH THE DEFINITIONS OF SECTION 24, AND HE IS, IN ADDITION, AUTHORIZED TO EXERCISE THE POWERS GRANTED IN THIS INSECTION DURING THE STATE OF EMERGENCY, UPON HIS SIGNING UNDER OATH A STATEMENT FINDING THAT A STATE OF EMERGENCY DOES EXIST; AND

WHEREAS, THE SUPERVISOR FINDS THAT IT IS EXTREMELY UNFORTUNATE AND SAD THAT THESE IMMIGRANT GROUPS ARE BEING USED AS PAWNS IN BOTH A NATIONAL AND INTERNATIONAL GAME OF CHESS AND THAT INCIDENTS MAY HAVE OCCURRED IN THE TOWN OF HAVERSTRAW AS WELL AS IN OTHER SUBURBAN COMMUNITIES IN WHICH BUSES/VANS OR CHARTERED VEHICLES HAVE DISCHARGED OR UNLOADED PASSENGERS WITHOUT SUFFICIENT W-9 CLOTHING, RESOURCES, FOOD, AND OTHER SUSTAINING ITEMS WITHOUT MEANS TO OBTAIN SHELTER; AND

WHEREAS, BASED UPON THE FOREGOING THAT TIME IS OF THE ESSENCE DUE TO INCOMING INCLEMENT WEATHER WITHIN THE HAVERSTRAW AREA AND THE IMMEDIATE INCREASE IN DEMANDS ON TOWN AND OTHER GOVERNMENTAL AGENCIES' RESOURCES RESULTING FROM THE DISCHARGE OF SAID PASSENGERS WITHIN THE TOWN, THE SUPERVISOR FINDS THAT A STATE OF EMERGENCY EXISTS; AND

WHEREAS, THE TOWN IS COMMITTED TO PROTECTING THE HEALTH, SAFETY, AND WELFARE OF INDIVIDUALS RESIDING IN AND VISITING THE TOWN; AND

WHEREAS, IT IS IN THE BEST INTEREST OF THE TOWN, IT'S EMPLOYEES, AND ITS RESIDENTS TO ESTABLISH A POLICY FOR THE STOPPING, STANDING, AND PARKING OF BUSES/VANS OR CHARTERED VEHICLES AND THE DISCHARGE OF PASSENGERS WITHIN THE TOWN; AND

WHEREAS, THE UNLOADING OF PASSENGERS IN INCLEMENT OR SEVERE WEATHER CONDITIONS WITHOUT A COORDINATED PLAN POSES A SIGNIFICANT THREAT TO THE HEALTH, SAFETY, AND WELFARE OF SAID PASSENGERS; AND

WHEREAS, BUS/VAN OR CHARTERED VEHICLE OPERATORS HAVE BEEN ATTEMPTING TO AVOID COMPLIANCE WITH THE POLICIES OF NEIGHBORING MUNICIPALITIES REGARDING PERMITTING REQUIREMENTS FOR UNSCHEDULED BUSES/VANS OR CHARTERED VEHICLES; AND

WHEREAS, IT IS IN THE BEST INTERESTS OF THE TOWN, ITS EMPLOYEES, RESIDENTS, AND VISITORS THAT THE TOWN IMPLEMENT ADDITIONAL RULES AND REGULATIONS (THE "RULES AND REGULATIONS") REGARDING UNSCHEDULED BUSES/VANS OR CHARTERED VEHICLES AND HOLD NON-COMPLIANT BUS OPERATORS ACCOUNTABLE FOR ENDANGERING THE SAFETY AND WELFARE OF THEIR PASSENGERS; AND

NOW THEREFORE, BY THE EMERGENCY POWERS VESTED IN ME AS THE SUPERVISOR OF THE TOWN OF HAVERSTRAW, I HEREBY AUTHORIZE THE TOWN, ITS POLICE DEPARTMENT, AND ITS EMPLOYEES TO IMPLEMENT THE RULES AND REGULATIONS AS SET FORTH IN EXHIBIT A, ATTACHED HERETO AND INCORPORATED HEREIN.

SECTION 1: EFFECTIVE IMMEDIATELY, I, THE TOWN SUPERVISOR OF THE TOWN OF HAVERSTRAW, DELEGATE TO THE CHIEF OF POLICE THE AUTHORITY TO TAKE ANY AND ALL LAWFUL ACTION NECESSARY TO PROTECT THE HEALTH, SAFETY AND WELFARE OF THE RESIDENTS AND CORPORATE CITIZENS OF THE TOWN, INCLUDING, BUT NOT LIMITED TO, THE ENFORCEMENT OF THE RULES AND REGULATIONS, AND THE AUTHORITY TO CITE AND TAKE OTHER APPROPRIATE MEASURES AGAINST THE PERSONS WHO DISOBEY THIS ORDER OR THE RULES AND REGULATIONS AFTER DUE NOTICE , EITHER ORAL OR WRITTEN HAS BEEN GIVEN.

SECTION 2: THIS ORDER DECLARED EFFECTIVE IMMEDIATELY AND SHALL REMAIN IN EFFECT FOR A PERIOD NOT TO EXCEED THIRTY DAYS.

SECTION 3: THIS EXECUTIVE ORDER IS NOT INTENDED TO, AND DOES NOT, EXCEPT AS SPECIFICALLY SET FORTH HEREIN, CREATE ANY RIGHT OR BENEFIT, SUBSTANTIVE OR PROCEDURAL, ENFORCEABLE AT LAW OR IN EQUITY BY PARTY AGAINST THE TOWN, ITS DEPARTMENTS, AGENCIES, OR ENTITIES, ITS OFFICERS, EMPLOYEES, OR AGENTS, OR ANY OTHER PERSON. THIS EXECUTIVE ORDER SHALL BE DEPOSITED AND KEPT IMMEDIATELY AVAILABLE ON FILE FOR INSPECTION IN THE OFFICE OF THE TOWN CLERK.
